

**Notice Inviting applications for appointment of Vice-Chancellor (Kulapati)

It is proposed to appoint the Vice-Chancellor (Kulapati) of Durg Vishwavidyalaya, Durg (C.G.), established under the Chhattisgarh Vishwavidyalaya Adhiniyam, 1973 (No. 22 of 1973), out of a panel, to be recommended by a Committee, constituted in terms of Section 13 (2) of the above mentioned Adhiniyam.

The Vice-Chancellor (Kulapati), being the academic as well as administrative head, is expected to be :-

- A visionary with proven leadership qualities, administrative capabilities as well as teaching and research credentials.
- He/She should be a distinguished academician, with a minimum of ten years of experience as Professor in a University system or ten years of experience in an equivalent position in a reputed research and/or academic administrative organization, as per the UGC Regulations on "Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and Measures for the Maintenance of Standards in Higher Education 2010".
- The maximum tenure for the post of Vice-Chancellor (Kulapati) is 5 (Five) years, or up to the age of 70 (Seventy) years, whichever is earlier.

Applicant should attach self attested copies of certificates/ relevant documents in support of his/her experience as per eligibility criteria and educational qualifications. All pages of the filled application should be signed.
