विश्वविद्यालय विद्यापरिषद् की स्थायी समिति की बैठक दिनांक 12/12/2019 में लिये गये निर्णय एवं विश्वविद्यालय कार्यपरिषद् में अनुमोदन की प्रत्याशा में विश्वविद्यालय के अंतर्गत संबंध समस्त महाविद्यालय/संस्थानों को शोध केन्द्र की मान्यता मान्य संशोधित विनियम क्रमांक 107 अनुसार दिये जाने अनुशंसा की गई है। अतः संशोधित विनियम क्रमांक-107 निम्नानुसार है।

Revised Regulation No. 107

[Recognition of the Research Centers]

The regulation is meant for the recognition of the research center. The Institution/College who desires to have a research centre should essentially fulfill the following criteria :

1. The Principal of the affiliated College or the Head of the institution have to apply in the prescribed format to the university for the Recognition of a research centre in the concerned subject.
2. The application for the recognition of a research center can be made round the year with an affiliation fee prescribed by the University from time to time. The annual fee for the research centre will be levied as specified by the University.
3. Only College qualifying the following criteria can apply for recognition of a research centre in a subject:
 - a. The Colleges is accredited by the National Assessment and Accredited Council (NAAC). The existing College with research Center should get NAAC accreditation in order to continue the research Center in the subjects.
 - b. The College is running the Post Graduate course in the subject since last 5 years and has acquired permanent affiliation from the university.
 - c. The faculty strength in the subject in which recognition is sought is not less than three with at least one Professor/Assistant Professor who is Ph.D. with 15 years of teaching experience with 10 Research papers published in Referred journals, completed one orientation & three refresher courses in concerned subject and a minimum of two faculty possessing Ph.D. degree at least one of which is Ph.D. supervisor in the affiliating university in the concerned subject.
 - d. The College has a well equipped library and adequate number of books in the subject for research and with subscription of five Indian and at least two International Journals (with ISSN number) in the concerned subject since last three years.
 - e. In case of research centre in the science subject, an adequate space in the form of laboratory is mandatory. The laboratory should also have specific research equipments.

- f. A minimum of three computer sets with internet facility in the department is essential for the research students.
- g. The principal/ Institutional Head of the recognized research centre will maintain a proper record of the attendance of all the research scholars registered at the centre and would authenticate and forward the same regularly with six monthly progress report to the University.
- h. In the above criteria of point 3, a relaxation can be provided by the Vice Chancellor according to the need, keeping in view the expansion of research work and student interest.
4. Nationally recognized Institutions will not be required to apply separately for recognition for a research centre They need to have a formal approval from the Research Degree Committee of the concerned subject of the University by making a formal request.
5. A Committee of the following will inspect the college/Institution on receipt of the application for recognition of a research center. The expenditure on inspection will be borne by the applicant institution.
 - (a) Dean (from the relevant Faculty).
 - (b) Chairman, Board of Studies of the Concerned Subject.
 - (c) A Subject Expert not less than University Professor/College Professor in the rank, nominated by the Vice-Chancellor.
6. The three member committee would inspect the application institution/college for the facilities/eligibility with number of seats and submit its report with the recommendation within a fortnight from the date of inspection to the Registrar of the University based on the criterion as laid down earlier at para 3.
7. The report of the committee will be presented at the RDC of the concerned subject for approval.
8. After the approval from the RDC, the matter would be placed in Executive Council for recognition of the basic Research center, and if approved by the EC, the research center recognition would be granted to the College/Institution.
9. The recognized Research center shall be entitled to collect the prescribed fees from the research scholars enrolled at its centre as laid down in the Ph.D. Ordinance of the University.
10. Recognized Research center will ensure all the basic facilities to the research scholars registered at their centers.
11. In case of any complaint the research center, the University will review the recognition status of the research center and if found true the recognition will be withdrawn with immediate effect.
12. Every research center will provide the details of the enrolled students annually to the university at the end of academic year or whenever asked.
13. In case on student is registered at the recognized research center in last five years, the recognition will be withdrawn and such centers have to apply afresh for recognition.
14. The University will review every five years the facilities at each recognized research center and if not found up to the mark, the recognition will be withdrawn from such centers.
15. Those institutions that were denied recognition earlier has to apply afresh as per the revised regulation for recognition of research center.
16. In case the guide(s) at a recognized research center superannuate (S) or is/are transferred from the research center, it shall be the duty of Principal/Head of Institution to maintain the record of the attendance of research scholar working at the research center and provide it to the University wherever needed.
