Chhattisgarh, hereinafter referred to as the "University", which expression shall, unless
repugnant to the context or meaning there of, include its successors and permitted assigns.

AND

Central India Institute of Mental Health and Neuro Sciences (CIIMHANS), having its
office at G.E. Road, Dewada Chowk, Kopedih Road, Rajnandgaon -491441, Chhattisgarh,
hereinafter referred to as the "CIIMHANS", which expression shall, unless repugnant to the
context or meaning thereof, include its successors and permitted assigns.

WHEREAS :

1. The Hemchand Yadav University is a recognized higher education institution under
the Chhattisgarh State Government, offering a variety of academic and vocational
programs including those in the domain of special education and rehabilitation.

2. The CIIMHANS is a recognized center of mental health and rehabilitation, with adequate infrastructure, trained personnel, and clinical resources to support academic training and field experience in mental health and allied fields.
3. The University is in the process of seeking approval from the **Rehabilitation Council of India (RCI)** to offer:
 - **Post Graduate Diploma in Rehabilitation Management (PGDRM)**
 - **Integrated Special Inclusive Teacher Education Program (ISITEP)**
4. As per RCI norms, the University requires collaboration with a recognized clinical/ rehabilitation CIIMHANS for practical training, exposure visits, and supervised practicum.

NOW, THEREFORE, THE PARTIES AGREE AS FOLLOWS:

1. Purpose of MoU

This MoU outlines the mutual agreement between the University and the CIIMHANS to facilitate academic collaboration and clinical training to fulfill the RCI requirements for PGDRM and ISITEP programs.

2. Scope of Collaboration

- Provide field training, practicum, and supervised clinical exposure to enrolled student.
- Facilitate orientation, demonstration, assessments, and community-based rehabilitation practices.
- Share faculty expertise and collaborate in research, seminars, and capacity building.

3. Responsibilities of the University

- Enroll and administer students for PGDRM and ISITEP programs in compliance with UGC and RCI regulations.
- Provide academic resources, curriculum, and course coordination.
- Maintain academic records, internal assessments and ensure certification after due process.

4. Responsibilities of the CIIMHANS

- Offer clinical infrastructure, including access to wards, counselling room, diagnostic labs, therapy units, etc.
- Assign trained supervisors (RCI registered, wherever required) for hands-on training.
- Issue training completion certificates to each student after successful fieldwork/ practicum.

5. Duration and Renewal

- This MoU shall be valid for a period of **five (5) years** from the date of execution and may be renewed with mutual consent in writing.

- Clinical posting charges (fee) will be 200/- (Rs. Two Hundred) per day per student which will be paid by Hemchand Yadav University to CIIMHANS.

7. Confidentiality

Both parties agree to maintain the confidentiality of information shared during the course of this collaboration unless legally required to disclose the same.

8. Dispute Resolution

Any dispute arising out of or in connection with this MoU shall be resolved amicably through mutual consultation.

9. Jurisdiction

This MoU shall be governed by and construed in accordance with the laws applicable in the State of Chhattisgarh, and courts at Durg shall have exclusive jurisdiction.
